Tax Credit Deadline for Tax Year 2022 – 4/18/23

Contributors may redirect any portion of their state tax liability (also referred to as income taxes) up to these maximum amounts:

For Tax Year 2022

- \$1,243 for single filers and \$2,483 for joint filers

For Tax Year 2023

- \$1,307 for single filers and \$2,609 for joint filers

Per state law, a school tuition organization cannot award, restrict or reserve scholarships solely on the basis of donor recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent.
